Justification:

According to A COMPARATIVE STUDY ON YOUTH PARTICIPATION IN CIVIC AND ELECTORAL PROCESSES FOR Kenya supported by UN, Fewer youths are aware of the institutions through which they could advance development and rights issues regarding their civic participation across the three countries. in Kenya, and 36% were able to identify institutions for advancing civic participation in their respective countries. 2.4Youth awareness of institutions and responsibilities in civic processes Across the countries, institutions identified include government ministries and structures as well as civil society organizations, including local community structures. However, the statics presented indicate that the

majority of the youth across the countries remain without knowledge of these institutions thereby compromising their participation in civic processes. Study findings show low levels of youth participation in development processes, The results also reveal that youth participation is lowest in project monitoring and evaluation across the county signifying low interest by the youth to hold community leaders accountable in the implementation of community development projects.

- To assess the level of youth participation and engagement in electoral processes, policy development, and governance in Kilifi-Kenya
- To establish challenges that hinder youth participation across Kilifi County
- To proffer recommendations for greater awareness and participation of youth in civic processes in Kilifi-Kenya.
- To finds ways of creating champions for youth civic rights participation who will collaborate with local government departments to promote youth involvement.
